INTRODUCTION

In February 2022 our civic association, like our entire society, was confronted with a completely new situation, which arose with the military invasion of Russian troops to the territory of our neighbor, Ukraine. We were one of the first to send mobile teams to our eastern border to help refugees and displaced persons. In addition to humanitarian aid and the provision of basic necessities, we have also provided psychological aid from the beginning, because the initial surprise and shock caused post-traumatic shock for many.

We are still dealing with the consequences of the war conflict on the mental health of adults and children, refugees and our citizens, too, and it is obvious that the challenges in this area are not abating. On the contrary, in connection with overcoming an unpredictable situation such as the pandemic and also the threat of its return, the needs for solving mental health problems are multiplying and in the coming years they will probably be a problem with the main priority.

With the significant support of foreign organisations such as UNICEF - Blue Dot, UNHCR, Médecines du Monde and WHO, we have been active in helping refugees from their first steps here, since the first days of the establishment of the Centre for refugees on Bottova in Bratislava. We continue providing them psychological help, and also finding job opportunities for the adults, schools and preschools for their children.

We have employed 30 Ukrainian citizens with psychological education, pedagogy and physiotherapy education who help their compatriots in their native language. We opened other help centres in Banská Bystrica, Košice, Žilina and Spišská Nová Ves.

Our mobile teams operate throughout Slovakia. We are trying to anticipate the challenges of the near future, therefore we are establishing a branch in Kyiv. This is to be related to the Ukrainian problem with a focus on sustainability.

In the fall of 2022, as one of several civic organisations, we became laureates of the symbolic White Crow award for helping Ukraine after the Russian invasion.

Our team has grown to 130 employees, which is also related to the restructuring of our management. Together with the general director/statutory representative and the operational director, there are also 6 program directors, 4 for support management, 3 regional directors and 2 representatives of the clinic and consulting room

OUR HISTORY



The Company establishment and core data:

TENENET o.z. was established in Senec in 2011 as a response to the needs of disabled people, families with children with disabilities. From the beginning this was meant to help finding employment for the long-term unemployed in our related organization WELLNEA s.r.o., This company is seen as an example of good practice of the registered social enterprise Back then, thanks to our support program and significant discounts for people in WELLNEA, especially women from socially weak families started contacting us and asking us for professional help.

OUR HISTORY

In the summer of **2013**, we expanded our activities to persons at risk of social exclusion thanks to the **SPOaSK accreditation** (305/2005 Z.z.), **specialised social counselling** and (448/2008 Z.z.) and **supported employment agency** (5/2004 Z.z.) and **subsequent registration** and **registration at the BSK** with ambulatory practice in the consulting room in Senec and in the field in the TTSK.

In **2015**, we expanded our social services to include **the Community Centre** and **Early Intervention Services**, which we operate in the **Jánovce** Community Centre, Galanta district on an outpatient and field basis for the entire Trnava region, and since **2016**, the **Community Centre** is also an outpatient one in **Senec** (operating in the Bratislava region).

Today we operate in 2 outpatient facilities - **Community centre KC Senec** (district Senec and Pezinok) and **Community centre KC Jánovce** (district Galanta) with field service in the Bratislava and Trnava regions.

Staffing was significantly strengthened thanks to the acquisition of **4 demand-oriented projects** (below) in **2017** aimed at the **implementation of measures for the social and legal protection of children and youth and social guardianship**, intended mainly for the wages of new professionals. And also in **2019**, thanks to the obtained **accreditation** of the all-Slovak Centre for Children and Families (§45 Act 305/2005 Coll. on **SPODaSK**), we obtained for the first time **the pilot project** of the Centre for Labor, Social Affairs and Family priorities of the centre **2019** according to the amendment. **Since 2019**, we also have **a license** for a non-state healthcare facility - **a clinic for clinical psychology and psychotherapy**.

By the decision of the **Ministry of Education, Science, Research and Sport of the Slovak Republic** from **September 1, 2022**, we are entitled to include our private (non-state) **Centre for Pedagogical-Psychological Counselling and Prevention (SCPPPaP)** as well as the private (non-state) **Centre for Counselling and Prevention (SCPP)** to the **network of schools and school facilities**. This year, the **organisation employs 147** full-time (part-time or full-time) employees. Specifically, the composition of 7 management and 140 professional workers, namely professional - social workers; psychologists, psychotherapists, special educators, social pedagogues, speech therapists and persons from Ukraine with psychological and pedagogical education.

4. is a full member of the **EASPD (European Association of Service Providers for People with Disabilities)**, namely the Standing Committee for Inclusion (de-institutionalization and social housing), where we deal with the main topics and problems of individual countries and the entire EU directly based on the UN Convention on Human Rights rights for people with disabilities and at least twice a year we meet in various EU countries at professional conferences and working meetings on de-institutionalisation and we prepare direct assignments from **the European Commission, the Council of the EU**,
5. we participate in **professional conferences** dealing with civil society, especially the contribution of the non-profit sector to the solution of EU social problems, which are organised around Europe by **the European Economic and Social Committee** as the main advisory body of the EU (expert advice to **the European Commission, the Council of the EU** and **the EU Parliament** through opinions on the proposed EU legislation and own-initiative opinions on issues that need to be addressed, creates a bridge between the EU institutions and organised civil society) - they involve us in a structured dialogue
6. we participate in **conferences** and **workshops** focused on the issue of social and work **inclusion of people with disabilities** organised in the EU by **ENIL - European Network on Independent Living**, **EDF - European Disability Forum**, **ESS - European Social Services**, etc.
7. thanks to the fact that our statutory representative is also acting as an **external teacher at FSEV UK** and our organisation is **actively cooperating** with several **departments of social studies** in Slovakia, we also have **experience** with **academic research**, either at the **national level (VEGA grants)** or at the **trans national level (DRPI - Disability Rights Promotion International** - research centre for monitoring the fulfilment of the UN Convention on the Rights of People with Disabilities, methodology developed directly by the **UN Commission** and **York University, Toronto**.

Altogether in 2022 we provided our services to **2,784** clients (approximately **1,330** families) from all over Slovakia in all the regions..

As part of the services of 2 community centres, we provided the social crisis intervention services at the community level to a total of **552** clients in both CCs (**CC Senec 203** clients, **CC Jánovce 349** clients). Through specialised social counselling, we attended to 77 clients, and through early intervention services, we attended to **126** child clients with disabilities aged 0-7 years.

Through APZ activities supported employment to **49** clients.

Through the implementation of SPODaSK measures, we provided our services to a total of **340** clients from disadvantaged backgrounds - from poor families in material need, integrated in primary school due to learning or behavioural problems, disabled children and young people, former abused children and young people, which were sent to us by social curators from the Office of Social Affairs and Family or educational counsellors from schools, etc.). We provided services to **1161** clients (922 children from 410 families from all over Slovakia) through the priorities of the headquarters (i.e. distributed from UPSVRs, SPODaSK department or by court decision). Through the implementation of SPODaSK measures as voluntary clients recommended by local governments, we attended to 401 clients (BSK, TTsK - 337), **94** clients within the counselling center for people in/ after serving a sentence in prison.

As part of our services in working with people from **Ukraine**, in 2022 we provided our services to **5,259** clients from Ukraine throughout Slovakia.

Through the implementation of SPODaSK measures, in 2022 we provided our services to a total of 340 clients from disadvantaged backgrounds - from poor families in material need, integrated in primary school due to learning or behavioural problems, disabled children and young people, former abused children and young people who were sent to us by social curators from the Office of Labor, Social Affairs and Family or educational counsellors from schools, etc.

We provided services to 1,161 clients (922 children from 410 families from all over Slovakia) through the priorities of the headquarters (i.e. distributed from UPSVRs, SPODaSK department or by court decision). Through the implementation of SPODaSK measures as voluntary clients recommended by local governments, we attended to 401 clients.



As of September 1, 2022, we also received the decision of the Minister of Education, Science, Research and Sport of the Slovak Republic to include our private (non-state) Center for Pedagogical-Psychological Counselling and Prevention (SCPPPaP) as well as the private (non-state) Center for Counselling and Prevention (SCPP) in the network of schools and school facilities.

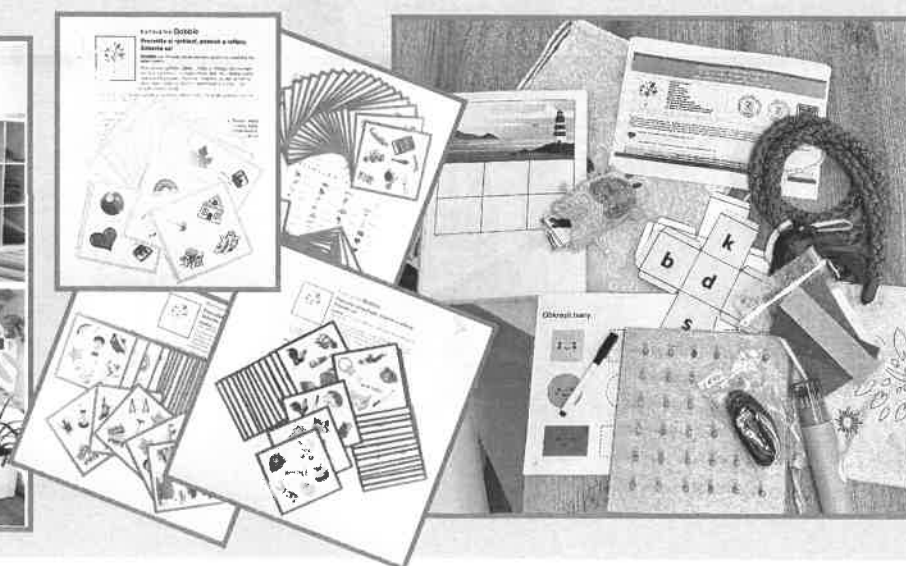


This year, the organization employs 147 full-time (part-time or full-time) employees. Specifically, the composition of 7 management and 140 professional workers, namely professional - social workers; psychologists, psychotherapists, special educators, social pedagogues, speech therapists and persons from Ukraine with psychological and pedagogical education.



Our special pedagogue, a speech therapist, a physiotherapist and a special psychologist participate in the preparation of tools for children with special needs. The project is led by the registered social enterprise WELLNEA s.r.o. under the name InluDidActive. The pilot testing went very well: 130 pieces of the Package for preschoolers were sold to VÚDPaP and are being successfully sold to preschools in Senec, Bratislava and Pezinok

English and Ukrainian versions of the aids are currently being prepared..



The activities of the Community Centers in Senec and Jánovce are sponsored by the civil association TENENET

In 2015, TENENET expanded social services to include the Community Center and Early Intervention Services, which we carry out in the Jánovce Community Center, Galanta district, on an outpatient basis and in the field for the entire Trnava region, since 2016, as an outpatient Community Center in Senec (field for the Bratislava region).

As part of the services of 2 community centres, in 2022 we provided our social crisis intervention services at the community level to a total of 552 clients in both CCs (CC Senec 203 clients, CC Jánovce 349 clients).

Through specialised social counselling, we attended to 77 clients, and through early intervention services, we attended to 126 infant clients with disabilities aged 0-7 years.

In 2014, we became a member of SUPZ - the Slovak Union of Supported Employment. At home, we are also members of ASSP - Association of Supervisors and Social Advisors.

In 2022, we helped 49 clients through APZ activities of supported employment.



In cooperation with the Ministry of Labour, Social Affairs and Family of the Slovak Republic, we participate in the preparation of calls for employment assistance for young people aged 18-29, which fall under the European Commission's ESF+ program and EaSI - Employment and Social Innovation. In 2022, we established the National Contact Point (NCP) at our headquarters at Oravská 4 in Senec. We regularly inform about the individual steps of ESF+ EaSI on the website and on social networks.

We also participate in the Step by Step project on, for example, the topic: Harmful effects of addictions on a person's work potential

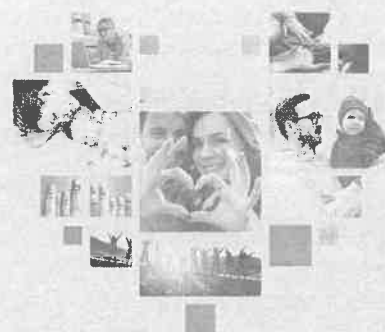

- conclude contracts with all health insurance companies, thanks to which we can help even patients who cannot afford direct payment services
- education of several colleagues within the specialisation in healthcare
- specific focus of one of our colleagues on children up to 6 years of age - education in play and filial therapy
- further education in the framework of psychotherapy - psychodynamic psychotherapy, catathymic-imaginative therapy, relational psychotherapy of children and adolescents
- we care for patients with depression, anxiety disorders, addictions, but also children with behavioural disorders or difficult relationships; we try to solve traumas together and go through difficult life circumstances
- we help doctors with diagnostics through psychodiagnostic examinations, but also people with disabilities when applying for a disability pension; we issue certificates of competence for working with children

The partners of the project are the following organizations: iSocial Foundation - Spain, Aunua - Ireland, ChanceB - Austria, TENENET - Slovakia, UAB - Spain. goal of the project is to identify barriers to the transition from education to employment and to help young people who feel psychologically uncomfortable. The output of the project is the creation of methodological material with working methodologies that will enable experts to provide better and targeted assistance to the aforementioned group of young people. Kália - counselling centres for women experiencing violence and for their children is aimed at expanding and improving the quality of counselling services in the Bratislava and Trnava regions.

Our goal is to provide help, support and protection for women and their children when dealing with violence from a husband/partner/father by providing specialised counselling so that they can start living an independent life without violence.

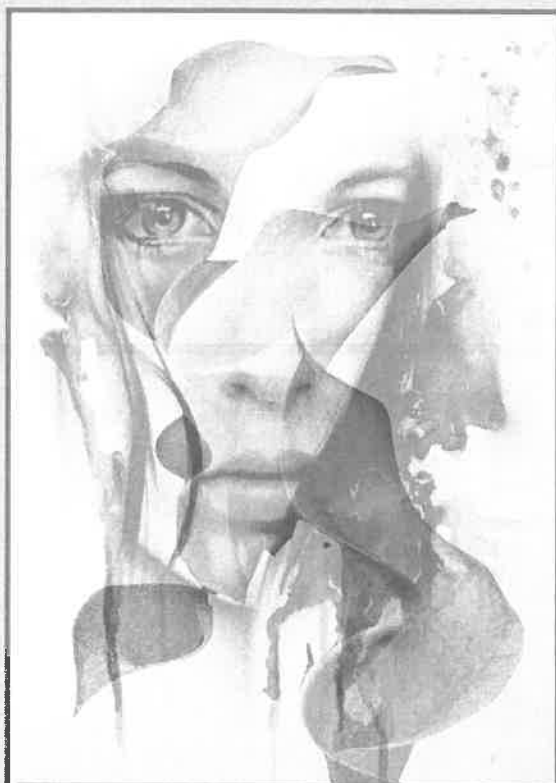
We provide consulting services as an outpatient as well as in the field. In addition to personal contact, they also provide telephone counselling or counselling via email communication.

Kália are two counselling centres in the cities of Senec and Trnava for women and their children experiencing domestic violence. Counselling centres represent a safe space for dealing with violence in partner relationships. The professional staff consists of a team of social workers and psychologists who provide support, help and specialised counselling services to women and their children experiencing violence.

What consulting services do we provide?

- Basic social counselling
- Specialised social counselling
- Psychological counselling
- Security management
- Crisis intervention
- Assistance in asserting rights and the right of protected interests
- Support services for children (psychological care and special pedagogical care)

POST/PENITENTIAL COUNSELLING

In the Institute for the execution of the sentence of imprisonment - the exit section (which is created by the project Chance to return) and the section for the execution of the sentence, we hold regular meetings.

These activities have been part of our COUNSELING OFFICE FOR PEOPLE AFTER AND IN EXECUTION OF SENTENCE for almost two years.

We have group activities with convicts twice a month in two different sections. Yes, someone will ask why we work with convicts, because they deserve their punishment. They have undoubtedly committed a crime for which they are serving their sentence in accordance with the law.

But on the other hand, the old ones are people with different life situations and stories that have influenced them in life. Our groups are focused on self-knowledge, anger management, aggression and many other topics that are always tailored to convicts.

In the department of punishment, 52 convicts applied for the initial meeting.

At the meetings, convicts are offered work on self-development and reflection on various situations in life that affect them in a certain way.

We spend the time that we have reserved on procedures necessary for anger management, we explain how to manage tense situations in the execution of a sentence, the possibilities of work and venting anger, how to accept the status of a convicted person.

A very important part of our work is paying attention to the family, strengthening the bond with the family, healing broken relationships, so what can I do, who is my role model, why is it my role model, how do I achieve these qualities.

We don't have rose-colored glasses, but since carrying out our activities directly in the prison, the number of voluntary clients after leaving the prison has increased. They are interested in working on a positive change in their lives without committing crimes.

ASSISTING CENTRES

Our psychologists/refugees from Ukraine with psychological education and special educators from TENENET provide specialised services and counselling for Ukrainian families in Center Bottova Bratislava, SPOT ON Banská Bystrica, Košice, Ukrajinský dom Žilina and in Spišská Nová Ves.

MOBILE TEAMS

We operate 2 mobile teams that respond to acute problems and challenges for people who have been provided counselling at points of first contact and who have subsequently been placed in accommodation facilities within Bratislava and the surrounding area.

Mobile teams consist of:

- Social worker (citizen of the Slovak Republic with a Bachelor's and/or Master's degree in Social Work)
- Psychologist (citizen of the Slovak Republic with a Bachelor's and/or Master's degree in Psychology)
- Crisis intervention worker at the community level (citizen of Ukraine with completed higher education M.Sc. in Psychology, Pedagogy, Pediatrician)

Mobile teams respond, among other things, to the provision of health care and the provision of advice on the nutrition of infants and young children.

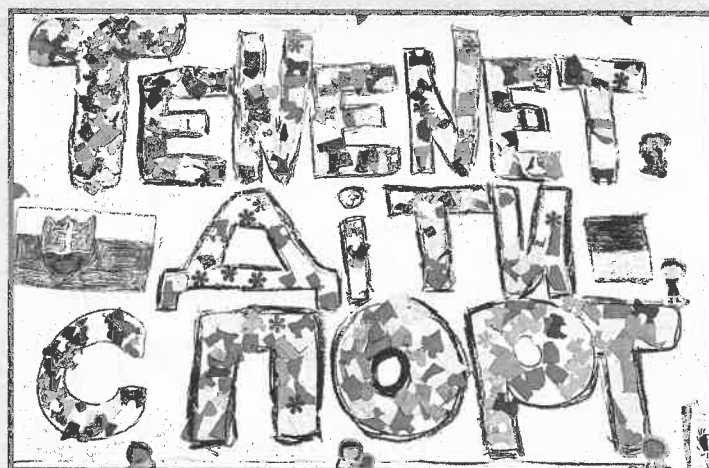
