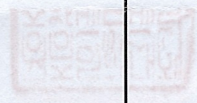



2. file the corporate income tax return (DPP) and financial statements and arrange closing accounting operations,
3. submit deregistrations with the Social Insurance Agency and health insurance companies and obtain clearance certificates,
4. submit applications to the Tax Authority, including the request for the Tax Authority’s consent with the Company’s deletion,

5. pripraviť, podpísať a podať návrh na výmaz spoločnosti z Obchodného registra SR vrátane všetkých príloh,
6. podpisovať, podávať, preberať a doručovať všetky podania, rozhodnutia, potvrdenia a výpisy súvisiace s vyššie uvedenými úkonmi,
7. vykonať všetky ďalšie úkony potrebné na úplné ukončenie činnosti spoločnosti až do právoplatného výmazu.



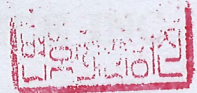

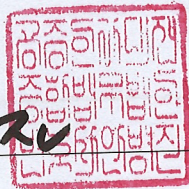
