## ROK 2020 V SEWA THE YEAR 2020 IN SEWA

Hneď v úvode sa chcem poďakovať všetkým našim partnerom, klientom, spolupracovníkom a kolegom. Úspechy, ktoré sme počas tohto roka dosiahli, boli možné len vďaka vám a vašej podpore. Uplynulý rok nebol jednoduchý pre nikoho z nás. Celosvetová pandémia nás zasiahla nečakane a od základov zmenila naše vnútorné nastavenia, denné rituály či pracovné vízie. Aj preto vám za vašu neustálu oddanosť a prvotriednu prácu patrí veľké ďakujem.

Som rád, že službám našej spoločnosti v súčasnosti dôveruje viac než 720 klientov. Legislatívou stanovené povinnosti pre výrobcov, dovozcov, predajcov, distribútorov sú značné komplexné a podliehajú neustálym zmenám. Garancia riešenia všetkých povinností na jed-

nom mieste „one-stop shop“ sa ukazuje ako výrazný benefit pre našich klientov.

Bezplatný zber elektroodpadu a batérií zároveň využilo 1 078 firiem, inštitúcií, miest, obcí a škôl, ktoré získali Zelený certifikát za pozitívny prístup k životnému prostrediu. V uplynulom roku 2020 sa nám tak podarilo zrecyklovať 10 321 ton elektroodpadu a 316 ton batérií. Aj napriek ešte stále pretrvávajúcej nepriaznivej situácii sa nám však toto množstvo neustále darí zvyšovať a to vďaka inovatívnym riešeniam, ktoré si súčasná situácia vyžaduje, profesionalite zmluvných partnerov a vernosti našich klientov. Zároveň je to pre nás dôkazom rastúceho povedomia o potrebe recyklácie tejto, v rámci odpadového hospodárstva dlhé roky prehládanej, komodi-

ty a záujmu verejnosti o čistejšie a zdravšie Slovensko.

V rámci vzdelávacích aktivít sme ani kvôli pandémie koronavírusu neustali s edukáciou už od tých najmenších a počas uplynulého roku sme spolupracovali so 489 školami a školskými zariadeniami. Podarilo sa nám tak doceliť vzdelávanie až 8 839 žiakov a študentov, čo mňa osobne ako otca veľmi teší.

Rok 2020 bol výnimočným aj s ohľadom na optimalizáciu nákladov na zber a recykláciu elektroodpadu a následné znižovanie recyklačných poplatkov. Už od 1. januára sme mohli uviesť do platnosti nový cenník poplatkov za recykláciu elektrozariadení – ceny sa nám podarilo znížiť v priemere až o 10 %.



K takémuto zásadnému zníženiu poplatkov došlo naposledy v roku 2018. Sme preto radi, že našim členom môžeme ponúknuť férové podmienky a najnižšie reálne dosiahnuteľné ceny.

Aj v roku 2021 sa budeme snažiť byť pre našich klientov tou správnou organizáciou zodpovednosti výrobcov, ktorá im vždy ponúka efektívne riešenia, aby sa tak mohli venovať svojmu podnikaniu. Zároveň chceme byť tými, ktorí budú prinášať vždy aktuálne informácie zo sveta recyklácie, legislatívnych povinností i elektroodpadov. Veríme, že aj tento rok budeme pre našich členov tým pravým partnerom a prajeme všetkým, aby sa im aj napriek nepriaznivej situácii darilo v pracovných i osobných životoch.

I would first like to express my thanks to our clients, partners, co-workers, and colleagues. Our achievements this year would not have been reached if it had not been for you and your support. The past year was not easy for any of us. The global pandemic has caught us up unexpectedly and fundamentally changed our mindset, daily rituals, and work aspirations. For this reason, too, I am very thankful for your continued loyalty and excellent work performance.

I am pleased that today more than 720 clients trust our services. The obligations of producers, importers, sellers, and distributors set by legislation are quite complex and subject to constant changes. The guarantee of dealing with all obligations in one place, the so-called "one-stop shop", proves to be a significant benefit to our clients.

At the same time, 1,078 companies, institutions, towns, municipalities, and schools used our free collection of WEEE and batteries, and they were awarded our Green Certificate for their positive approach to the environment. This way we recycled 10,321 tonnes of WEEE and 316 tonnes of batteries in 2020. However, we constantly increase these volumes despite the continuing unfavourable situation, also thanks to innovative solutions required by the current conditions, professional approach of contracting partners, and loyalty of our clients. This, in our opinion, is the evidence of growing awareness of the need for recycling this commodity that had long been a neglected part of waste management and the interest of the public in cleaner and healthier Slovakia.

In terms of educational activities, not even the Covid-19 pandemic could stop us from educating our children and pupils. We cooper-

ated with 489 schools and educational facilities last year. And being a father myself, I am personally delighted that we managed to educate as many as 8,839 pupils and students.

The year 2020 was extraordinary, also considering the optimisation of cost on the WEEE collection and recycling and subsequent reduction of recycling fees. That is to say, from 1 January we put into force a new price list of EEE recycling, and we managed to reduce the prices by as much as 10% on average. The last time we could reduce the fees in such a significant way was back in 2018. For this reason, we are pleased that we can provide fair conditions and the lowest realistically achievable prices to our members.

In 2021 we will continue to strive to be the right producer responsibility organisation for our clients, always offering efficient solutions so that they could pursue their business. We also want to be an organisation that always brings up-to-date information from the world of recycling, legislative obligations as well as EEE. We do believe that also this year we will make the right partner for our members, and we wish them all to succeed both in their professional and personal lives despite the unfavourable situation.

# ÚVODNÉ SLOVO

## INTRODUCTORY WORD

V roku 2020 sme boli postavení pred krízu spôsobenú celosvetovou pandémiou – zasiahla náš trh, ekonomiku, pracovné a sociálne vzťahy. Ani táto kríza však nedokázala zastaviť nárast produkcie elektroniky. Došlo skôr k opačnému trendu, väčšina ľudí pracujúcich v kanceláriách musela prakticky zo dňa na deň presunúť svoje pracovné činnosti do domácností, na home office. Okrem toho sa mnohí študenti museli prispôbiť a prejsť na online výučbu. Oba spomenuté faktory vyústili k potrebe nákupu väčšieho počtu výpočtovej techniky do rodín, firiem a školských zariadení. Tento trend sa premietol nielen do nárastu množstiev elektrozariadení uvedených na trh

klientmi SEWA, ale aj do rastu produkcie elektroodpadu. V porovnaní s predchádzajúcim rokom stúpol zber elektroodpadov realizovaný prostredníctvom SEWA v roku 2020 o 33 %. S rastom záujmu o elektroniku a jej zväčšenou mierou spotreby, s ktorou sa v posledných rokoch stretávame, sa však musí zväčšovať aj záujem o bezpečnú a správnu recykláciu tohto druhu odpadu.

Som preto rád, že aj v minulom roku sa nám darilo byť vyhľadávaným partnerom pre výrobcov a dovozcov elektrozariadení nielen na Slovensku, ale aj v mnohých európskych krajinách. Naďalej sa nám darí zostať najväčšou organi-

záciou zodpovednosti výrobcov pre elektrozariadenia na Slovensku, čo sa týka počtu členov (výrobcov elektrozariadení) a komplexnosťou služieb. Verím, že je to docielené nielen vysokou kvalitou našej práce, ale tiež strategicky vhodne nastavenou firemnou politikou, založenou na možnosti plnenia všetkých legislatívnych a administratívnych povinností pod jednou strechou. Teší ma, že myšlienka, s ktorou sme – IT Asociácia Slovenska (ITAS) a Asociácia audiovizuálnych technológií (ADAT) – v roku 2005 zakladali spoločnosť SEWA sa nielen pretavila do reality, ale tiež sa udržala aj po toľkých rokoch. Dôkazom toho môže byť aj fakt, že nám medziročne stúpol počet klientov

z 676 na 719 – tento nárast pre nás predstavuje dôvod na vďačnosť za prejavenu vernosť i motiváciu napredovať a byť stále lepšími.

Taktiež by som chcel oceniť úspechy našich vzdelávacích projektov. Ich význam neutíchol ani počas pandémie a aj v minulom roku sa nám podarilo vzdelávať mnohé deti a žiakov z materských, základných i stredných škôl. Ich dôležitosť možno nie je podstatná pre naše súčasné fungovanie, no nepochybujem, že ich pomyselné plody budeme zbierať v budúcnosti, keď z týchto mladých ľudí vyrastie generácia dospelých, ktorej záleží na životnom prostredí a budúcom obraze krajiny.

In 2020, we had to face the crisis caused by the global pandemic. It hit our market and economy, as well as our working and social relationships. However, it could not stop the growth of electronics production. The trend was actually the opposite. Most of the people with office jobs had to start working from home almost from day to day and found themselves in their home offices. In addition to that, many students had to adapt to the new situation and adjust to online instruc-

tion. Both of these factors resulted in more IT equipment purchases by families, companies, and educational facilities. The trend is reflected not only in an increased quantity of EEE placed on the market by SEWA clients, but also in a higher generation of WEEE. Compared with the previous year, the collection of WEEE through SEWA increased by 33% in 2020. However, along with the growing interest in electronics and the increased rate of consumption witnessed in recent years, also the interest in safe and proper recycling of this type of waste needs to be stepped up.

Therefore, I am glad that, also in the past year, we succeeded in being a sought-after partner for EEE producers and importers not only in Slovakia, but in many European countries, too. We still remain the largest producer responsibility organisation for EEE producers in Slovakia in terms of our membership base (EEE producers) and the comprehensiveness of our services. I do believe that this is thanks to the high quality of our work, as well as owing to the strategic and adequate set-up of our business policy which is based on the possibility to fulfil all legislative and administrative

obligations under one roof. I am pleased that the vision based on which we – the IT Association of Slovakia (ITAS) and the Association of Audio-Visual Electronics (ADAT) – established SEWA back in 2005 was not only transformed into reality, but we have kept it alive for so many years. This could also be shown by the fact that the number of our clients grew from 676 to 719 on the year-on-year basis. This increase is a good reason for us to be thankful for your loyalty, and it motivates us to go forward and constantly improve.

I would also like to highlight the achievements of our educational projects. Their importance did not diminish during the pandemic, and last year we educated many children and pupils attending kindergartens, elementary, and secondary schools. Our educational projects might not seem so essential for our current operations, but I have no doubt we will reap their benefits in the future when these young people become a generation of adults who care about the environment and the future landscape of their country.



**WEEE and waste batteries** do not belong to communal waste! There is no special coloured container for separated communal waste purposes. However, they still can be discarded in an environmentally friendly manner, namely in several ways:

⊕ Väčšie kusy elektroodpadu zaviezť na zberný dvor v mieste bydliska. / Larger pieces of WEEE need to be handed over to a collection site in the place of residence.

⊕ Použité batérie odoberú v ktorejkoľvek predajni, kde predávajú nové batérie. Pri väčšom množstve je možné ich odovzdať na zbernom dvore. / Waste batteries are collected by every shop selling new batteries. Larger quantities of waste batteries can be handed over to a collection site.

⊕ Veľmi malý elektroodpad ako mobil, fén, kalkulačka, rádio, tablet, holiaci strojček a pod. s vonkajším rozmerom do 25 cm je možné odovzdať v najbližšej predajni elektra. / Very small WEEE, such as a mobile phone, hairdryer, calculator, radio receiver, tablet, electric shaver and the like with outer dimensions not exceeding 25 cm, can be handed over in the nearest electronics shop.

⊕ Pri kúpe nového elektrozariadenia, odovzdať starý spotrebič rovnakého druhu v elektropredajni v rámci spätného zberu. / When buying an appliance, the old appliance of the same type can be handed over to the electronics shop as part of take-back collection.
