1. Introduction

- 1.1. EDYN is non-profit organization established for the purpose of providing general interest services.
- 1.2. The European Democracy Youth Network (EDYN) is a coalition of political and civic leaders, united by the desire to empower a new generation of changemakers who defend the freedoms their parents fought for. EDYN supports young pro-democracy activists, politicians, and journalists from across the political and ideological spectrum from 23 European countries with totalitarian heritage. EDYN supports those who refrain from the policies of hate and divisiveness in order to unite their societies against authoritarian revisionists.
- 1.3. The Annual report is issued based on the Act and is regarding the period 01.01.2021 – 31.12.2021.

2. The Annual report contents

2.1. An overview of the activities carried out in the calendar year, indicating the relationship to the purpose of establishing a non-profit organization:

- **EDYN Website** (3 workshops with members, 2 focus groups, web development)
- **EDYN Opening, LC meeting and Ribbon-Cutting Ceremony** in Bratislava, July 2021 (90 guests, 17 international)
- **EDYN Brand Building and Social Media** Communication (EDYN identity definition, new hire, 7 new countries with own social media, 3 new promo videos, social media activity strategic and operational planning, membership cards, pins, branding and social media guidelines)
- **Recruitment coordination**, September 2021 (70+ new members in 16 countries)
- **Membership Engagement Fund coordination**, September 2021 (so far 7 approved projects awarded worth 35k USD)
- **Annual Conference in Tirana**, November 2021 (external communication, communication with participants and logistics - partially, agenda design - marginally)
- **Leadership Council Election coordination**, November-December 2021 (3 presidential candidates, 13 LC candidates)
- **EDYN field offices coordination** (slowly taking over the coordination and communication with the IRI and NDI field officers)
- **Country Chapter development** (AL, XK, SB, NM, UA (virtually only), CZ, SK country visits and development, coordination/update mechanism created)
- **Partnership and Fundraising outreach** (US, GB, EU, SK visited, first fundraising talks, first donations and in-kind contributions secured from external sources, first partnerships: Atlantic Council interview, CoD Youth Assembly, WB summit panel).

2.2. Annual financial statements and evaluation of the basic data contained therein

The Board of Trustees became acquainted with the financial statements and had no further questions or inquiries. The Board of Trustees approved the financial statement.

2.3. The opinion of the auditor on the annual financial statements:

- On the 22nd of December 2021 the Board of Trustees approved the change of the EDYN n.o. registered seat from the address: **Zámocká 6619/2, 811 01 Bratislava, to the new address: Štefánikova 6/A, 811 05 Bratislava**, the proposal for the change of register seated to the relevant register was submitted on the 8th of March 2022.


